Jeff Determan, K-12 Principal, reported on student activities. He reported on the ICU Program, the in-service for the teachers concerning the miss use of prescription drugs, the upcoming band/chorus trip, and the starting season for track and golf.

Sara Klein, Superintendent, reported that the heating cooling system in the elementary is still not working properly. The dirt at the track has settled and dirt needs to be moved in and grass needs to get planted. The long jump pits need sand. There is a lot of work that needs to be done before the SCC track meet will be held in Gregory on April 2.

Mrs. Klein informed the board that the Gregory Track Meet will be held April 11, 2013. Gregory has not had a track meet for two years therefore other schools have taken the dates that they originally had. It was moved by Pochop and seconded by VanDerWerff to amend the 2012-13 school calendar to allow an early out for grade 7-12 at 11:30am on April 11 in order for staff to help run the track meet. School Board Election will be held April 9, 2013 from 7:00am to 7:00pm in the Community Room at the auditorium. The following candidates will be running for two positions: Sharon Pedersen, Karen Timanus, Chris VanDerWerff, and Rod Vosika.

Mrs. Klein gave a legislative update. The school will get a 3% increase in State Aid which amounts to \$135.00 per student and a onetime 1% increase in the amount of \$45.00 per student. Property tax levies were reviewed and the sentinel program was discussed.

The Harry K Quality Educator Award had 49 nominations for 35 teachers in 12 schools districts. The Gregory School District nominees are: Rhonda Waterbury, Jim Larkin, Jana Winters and Kristen Jacobsen. Congratulations to these nominees.

It was moved by Pochop and seconded by Sinclair to approve a new trust and agency account entitled Academic Incentives. Yes: All present. Motion carried. This account will be set up to buy incentive gifts for students. Proceeds coming from fund raisers.

It was moved by Sinclair and seconded by Stukel to approve the request from Mike Gassen to pay out his 2012-2013 contract by June 15, 2013. Yes: All present. Motion carried.

It was moved by VanDerWerff and seconded by Sinclair to approve the open enrollment #15-12 and #16-12 for the 2012-13 school year. Yes: All present. Motion carried.

Mrs. Klein presented the 2013-14 School Calendar. Discussion was held. The board had some questions about parent-teacher conferences. It was tabled for approval until the April board meeting.
