Superintendent Anderson stated that both of the holiday concerts were held and that both went very well. The Gregory School oral interp program received a plaque for their performance at state. In order to receive a plaque a team needs to receive two superior ratings. The following students received a superior: Keeley Klein and Christian Spann in the duet category, Samantha Timanus in humorous, and Kodi Timanus in poetry. The first semester ends on December 18<sup>th</sup>. There will be no cumulative semester tests. The second semester will start on Monday, January 4<sup>th</sup>. The special education review was held on December 1<sup>st</sup> and it went smoothly. A state fire inspector was at the school. The findings will be reviewed and corrective actions will be made. The insurance claim for damages to the buildings was received. A meeting with the buildings and ground committee will take place this spring to make plans for the repairs. The audit was received by the board and it will need to be reviewed and approved at the next meeting.

Shoemaker reported on Mid-Central Education Coop and that there was no meeting held this month.

Karen Timanus reported on CORE that they had a regular meeting. Two cars were sold as surplussed items.

Hull reported that she attended the virtual delegate assembly. Hull stated how important it is to be involved in the process and to get to know your local representatives. Anderson stated that she will contact our local legislatures about coming to the school to meet with the school board before the next session begins.

There was a boys' basketball parent/player meeting last week that involved discussion of the Burke School Districts proposal of a boys' basketball coop. Board members Shoemaker and Hull attended the meeting due to the fact they are appointed board members of the activities/cooperative committee. The proposal was explained and presented to the participants of the current boys' basketball program in grades 7-12. Overall, the student athletes and parents were not in favor of a coop. President Timanus shared a text received from Renee Thomas in support of a coop. The board agreed that this is not the right time to have this conversation, for the season is just beginning. The board agreed to meet with the Burke coop committee and/or the Burke School board in the spring of the year regarding this issue.
