**REGULAR BOARD MEETING CONTINUED**

Superintendent Anderson stated that there will be a pep rally for the boys' basketball team on March 13<sup>th</sup> at 8:15 am before they head out to state. There will be a sendoff for the team as they head to Aberdeen. Gregory will play De Smet in the first round on Thursday, March 14<sup>th</sup> at 6:00 pm. The middle school band participated at the Tri-City Music Festival in Chamberlain on March 11<sup>th</sup>. Large group band and choir contest is in Chamberlain on March 20<sup>th</sup>. The middle school play will be performed March 22<sup>nd</sup> and 23<sup>rd</sup>. All State Band is March 22<sup>nd</sup> and 23<sup>rd</sup> in Pierre. March 25<sup>th</sup> is the high school Gregory Invitational Track Meet. There is an early dismissal at 1:30 pm on March 28<sup>th</sup>, and no school on March 29<sup>th</sup> and April 1<sup>st</sup> for Easter Break. April 6<sup>th</sup> is the 5<sup>th</sup>-8<sup>th</sup> vocal contest and 3<sup>rd</sup>-8<sup>th</sup> piano contest in Gregory. Prom will be on April 6<sup>th</sup>. Tin had been delivered and installed at the school for the hail damage repair. Anderson will look to get an update on how much more is to be done before the project is completed. Service agreements with various vendors are being looked into, especially for the HVAC system. The Gregory School District used to be in a service agreement with Johnson Controls for the HVAC system and will look at getting on one again. Different Perkins reports are due at the end of the month are being completed. CORE had a regular meeting.

Cara Hull gave an update on the current legislative session.

Jason Frasch reported on the latest meeting that Mid-Central Cooperative held.

**Old Business:**

An annual election will not be conducted because there was not a contested vacancy on the school board. This is required to be noted in the school board minutes per SDCL 13-7-30. Two petitions were submitted for the two vacancies. Cara Hull and Amy Keiser will be sworn in for 3-year terms at the July school board meeting.

**New Business:**

It was moved by Schweigert and seconded by Hull to approve hiring of Wilson Santiago, head golf coach, for the 2023-24 school year at an extra duty pay rate of \$4,862.00. Yes: All present. Motion carried.

It was moved by Timanus and seconded by Frasch to approve termination of Jared Schmitz effective February 22, 2024. Yes: All present. Motion carried.

It was moved by Bolander and seconded by Frasch to approve hiring of Elsa Coc Reyes, custodian, at an hourly rate of \$15.00 for the 2023/24 school year. Yes: All present. Motion carried.

It was moved by Bolander and seconded by Frasch to approve resignation of Wendy Stukel, math instructor and senior class advisor, at the close of the 2023-24 school year. Yes: All Present. Motion carried. The board thanked Mrs. Stukel for her years of service to the Gregory School District.

It was moved by Schweigert and seconded by Hull to approve executive session for negotiations, SDCL 1-25-2(4). Yes: All present. Motion carried. Entered executive session at 6:14 pm. Exited executive session at 7:13 pm. No motions made upon exit.

The school board discussed the opt out for the Gregory School District. When the current opt out was initially passed, it was to pay for three additional elementary teachers. At the time, \$160,000 was enough to pay for the three additional teachers. Currently, \$160,000 is not enough to pay for the three additional teachers. With the increase in the number of elementary students, an additional elementary teacher may need to be hired. The increase of the opt out to \$275,000 is to cover the expense of the three additional teachers that were hired initially as well as if another teacher is hired. If a fourth teacher is not hired, the board will only request what is needed to pay for the three additional teachers and not the entire \$275,000. This opt out will be for three years.

It was moved by Hull and seconded by Frasch to offer the following resolution:

The GOVERNING BOARD of Gregory School District 26-4 do state that the above said board is unable to operate under the tax limitation measure currently in statute for the general fund. We therefore OPT OUT of such tax limitation in the amount of \$275,000 starting with calendar year 2024 taxes payable in the calendar year 2025. This opt out will be for 3 years, which will be through taxes payable in the calendar year 2027. This action has been taken by the board and approved by at least a two-thirds vote of the board.

This decision may be referred to a vote of the people upon a petition signed by at least five percent of the registered voters in the district and filed with the governing body within twenty days of the first publication of this decision.

Unless this action is referred to a vote of the people and reversed by such vote, this resolution authorizes the county auditor to spread an excess levy to raise tax dollars in the above stated amount.

Upon roll call vote: Karen Timanus - Yes; Todd Schweigert – Yes; Jason Frasch – Yes; Cara Hull – Yes; Katie Bolander– Yes.

Resolution passed by unanimous vote.

It was moved by Schweigert and seconded by Timanus to adjourn the board meeting at 7:17 pm. Yes: All present. Motion carried.

The next board meeting will be Tuesday, April 9, 2024 at 5:30 pm.
