Visitors to the board meeting: Jason Bartling was present to ask the board if they would reconsider their decision on letting people stand on the track.

Superintendent Klein gave the administrative report. Klein reported to date the enrollment is 378. She informed them of the teacher/student fund raiser for the Roeder fire and homecoming events that would be happening. The ICU(a program to help student's complete assignments) is ready for middle school students this nine weeks and will start for high school students next nine weeks. Klein discussed Initiated Measure 15 which is the penny sales tax increase. This increase in funding would be about \$725.00 per student. There was board discussion on holding a public forum. The penny sales taxes will help students and also Medicaid funding. Klein discussed the new heating and cool system in the elementary. In several rooms the units are not working properly.
