Jason Bartling and Scott Anshutz were present to discuss more seating for the football stadium or purchasing a mat for people to stand on to watch the game. Discuss was held. The board made no motion concerning this matter.

Billie Sutton was present to discuss election year ballot issues.
Superintendent Klein updated the board on the completion of the track, heating system, and QZAB loan. The public is asked to stay off the track surface. Drying time is taking longer because of cooler weather. Klein reported that the Sodak Bowl in Sioux Falls has invited the football team back for the next two seasons. Klein explained that this would mean giving up two home games leaving only three home games per season. Discussion was held. It was moved by Pochop and seconded by Sinclair to accept their invitation. Yes: All present. Motion carried.

Principal Determan discussed the school activities. Middle school football is finished, Cross Country Regions are Thursday Oct $11^{\text {th }}$, State Cross Country State is Oct $20^{\text {th }}$, State Cheer is Oct $19^{\text {th, }}$ All State Chorus $25^{\text {th }}, 26^{\text {th }}$ and $27^{\text {th }}$, football playoffs start Oct $23^{\text {rd }}$, and Volleyball Districts start on Oct $30^{\text {th }}$. No school on Oct $22^{\text {nd }}$. The ICU program is up and running with great reports from the staff. Parent/teacher conferences will be Oct $25^{\text {th }}$ from 4:00 to 8:00.

It was moved by Pochop and seconded by Stukel to accept the bid from Jerry's Electric for $\$ 41,802.64$. This project is to be completed over Christmas vacation. A penalty of $\$ 500.00$ per day will be enforced if not completed by Jan $3^{\text {rd }} 2013$. Yes: All present. Motion carried. $\$ 30,000.00$ will come out of Food Service Fund and $\$ 11,803.00$ out of Capital Outlay Fund. Bids will be taken for the two old coolers and one old freezer.
t was moved by Pochop and seconded by Stukel to appoint Curt Sinclair to be the ASBSD Delegate Assembly Representative in Pierre in November. Yes: All present. Motion carried.

It was moved by Stukel and seconded by Sinclair to approve the QZAB Resolution in the amount of $\$ 426,000.00$. Yes: All present. Motion carried.

It was moved by Sinclair and seconded by Pochop for board members to attend the SDASB Regional Meeting to be held October $10^{\text {th }}$ at the Gregory Auditorium Community Room without pay. Yes: All present. Motion carried.

It was moved by Pochop and seconded by Stukel to have a Special Board Meeting Wednesday October $24^{\text {th }} 2012$ at 7:00pm at the Gregory Memorial Auditorium to discuss IM15. Anthony Timmanus, Avera Gregory Healthcare Center Administrator, will also be present to discuss with people the importance of IM 15 to the medical field. The message is if the penny sales tax would pass we would not have to have an opt out. Stukel and Pochop requested fund balance information for this meeting to help inform the community that money is declining and increase funds are needed to educate our students. Peg Glover, high school English teacher, has asked to come to discuss HB 1234.
