Principal Determan's report was given by Superintendent Anderson. Winter athletics are over and golf and track will be starting soon. Gregory is hosting the Tri-City Band Festival on March 9th at 6:30 pm. The 3rd quarter ends on Wednesday, March 11th. Seniors are going to Pierre for the legislative session on March 11th. There is no school on March 12th and 13th for spring break. Donkey basketball, which is being put on as a fundraiser for post-prom by the junior parents, will be at the auditorium on March 17th at 7:00 pm. Large group music contest will be in Mitchell on March 18th. East/West basketball shootout, sponsored by the Gregory Athletics Club, will be held at the auditorium on March 23rd. High School all state band will be on March 27th and 28th in Mitchell. Samantha Timanus made the high school all state band. The middle school play will be held on April 3rd and 4th. Early dismissal on April 9th at 1:30 pm for Easter break.

Superintendent Mrs. Anderson reported that the Homeland Security grant for audio/visual entry was submitted February 28th, as well as the 21st Century grant for after school funding for the Gregory School District. An architect was contacted to look at the elementary center corridor. The architecture firm stated there would be a fee to give an estimate, so Anderson is going to pursue other options. There were no petitions turned in for the school board opening. The board will appoint someone to serve at the July 2020 school board meeting.
