Repairs from the hail damage are still being waited on to be completed. There are several LED lights in the school that are not working. GenPro has been contacted to fix the lights. Plans were sent off in regards to a new interior camera system. Headstart purchased a Promethean board for the preschool/headstart room. The punch list for the elementary remodel was made and there will be given seven days to complete the work that can be done.

Principal Determan said that school pictures are September 13-16. The marching band will be competing at Parker and Platte the next two Fridays. Mid-term for the first quarter is September 21st, with an early dismissal that day. Homecoming is the week of September 26-30, with coronation on the 26th and the parade on the 30th at 1:00 pm.
